2023 Bills

Abolish Abortion Oklahoma

Abolition Bill

SB402 (Hamilton - Senate HHS)

- Removes prohibition of prosecution for the mother in Title 12, Section 1053. Also removes language providing exceptions to culpability of abortion providers.
- Removes prohibition of prosecution for the mother in Title 21, Section 652.
- Removes prohibition of prosecution for the mother in Title 63, Sections 1-730 and 1-738.3f.
- Adds new law in Title 21 which brings abortion under Oklahoma's murder statutes.

Criminalization Bill

SB287 (Hamilton – Senate HHS) – removes prohibition of prosecution for the mother in Title 63, Section 1-731.4.

Exception Bills

HB1656 (McEntire) – adds exceptions for rape, sexual assault, and incest reported to law enforcement.

HB2088 (Echols) – adds exception for abortion for preborn babies with "terminal" conditions to allow organs to be used for transplant.

SB834 (Daniels – Senate HHS)

- Adds exceptions for rape, sexual assault, and incest reported to law enforcement, as well as for the mother's physical, psychological, and emotional health.
- Protects IVF, infertility treatments, and removal of dead unborn children and ectopic pregnancies.
- Also repeals Title 63, Section 1-733, the state's statutory prohibition of self-managed abortions (there is no penalty connected to this section).

Contraception Bills

SB232 (Garvin – Senate HHS) – allows pharmacists to prescribe and dispense oral and injectable contraceptives under collaborative practice agreements with a doctor (much like is currently done by Nurse Practitioners).

SB931 (Garvin – Senate HHS) – amends definition of "practice of pharmacy" to include the dispensing of self-administered hormonal contraceptives and any nicotine replacement therapy produced and approved by the FDA.

Embryonic Research Bills

SB936 (Dahm – Senate HHS) – outlaws non-therapeutic treatments (research) on human embryos.

Other Bills

HB1788 (Maynard) – provides for state tax credit for donations to pregnancy resource centers.

HB1985 (Maynard), SB656 (Bullard – Senate Judiciary) – extends child support responsibilities to preborn children (excludes any responsibility to assist in paying for an abortion).

HJR1044 (Munson) – ballot referendum for state constitutional amendment protecting abortion.

SB368 (Garvin – Senate HHS) – protects contraceptive drugs, surgeries, IVF, and other treatments.

SB538 (Treat – Senate HHS) – amends the Choosing Childbirth Act (provides grants to encourage women to choose to not have an abortion).

SB731 (Dahm – Senate HHS) – amends the definition of abortion in Title 63, Sections 1-745.32 and 1-745.51 to mirror Section 1-730.

HJR1012, HJR1013, HJR1014 (McCall) – pro-life shell resolutions (only contains a title) for ballot referendums.
